PART 5 - SCOPE

The Scope is as follows:

Mareeba Community Housing Company (MCHC) seek suitably qualified respondents to undertake the exterior painting on 24 dwellings in Mareeba and Mount Molloy..

The 24 dwellings are single-story with a building envelope construction of a rendered, painted blockwork walls and Fiber Cement Sheeting. It has been observed that the building envelopes are showing signs of paint fading and will require repainting.

Site preparations:

The contractor will undertake the necessary preparations for clear access to equipment and material to complete the Works.

The contractor will conduct a site clean of the building envelope to remove any cracked or flaking paint, chalky surfaces, along with any dust, dirt, mould, etc. that can affect the application of paint.

Scaffold:

The contractor will be responsible for the supply and complete installation of temporary scaffolding a to safely access the exterior walls. Scaffold plans, scaffolding tickets and certification is to be provided to the Principal for the commencement of the Works.

Painting works:

MCHC requires new paint applied to all exterior surfaces and is to match the original colour scheme.

- The contractor is responsible for the supply and complete installation of repainting which includes but is not limited to external walls, soffit, eaves, fascia etc., and other incidental or consequential work which is or may become necessary to complete the work.
- The contractor is responsible for removal of all excess material and rubbish.
- External paint selection should be Dulux weather shield or equal. Colours to be discuss with MCHC representative and should be confirmed on site before application. (Colour codes for the colour arrangement to be provided to MCHC for future mamaintence.)
